"What do you want me to do? Go and rent a car," she spoke sternly.

"See Mam, first of all, I have never driven in the USA. Besides, I can't afford to rent a car every time I need to go somewhere. I am looking for public transportation."

"I don't understand what you want. I am very busy here. I can get you a cab," she seemed to be at her wit's end

"How much will that cost?"

"The luxury cab will cost you \$105 plus tip and a regular cab will cost \$85 plus tips for going to Troy," She answered dismissively.

"Well Mam, I am an ordinary tourist. That would be quite expensive for me. Can I share the ride with other passengers?"

"No, you'll have the entire cab to yourself," she answered.

I made a quick calculation. That would have been 11% of my monthly salary in India. "So, how do the ordinary people like me commute here?" I asked.

"They have their own cars," she answered.

"But how about foreign visitors like me who want to travel the great city of Detroit and the pure state of Michigan?"

"None of my business," She snapped to shut me up.

Coming out of imposture, the whole experience seemed very puzzling to me. America's infrastructure used to be an example for the rest of the world. Almost from the beginning of the republic America built canals and roadways. In the 19th century a transcontinental railway was constructed linking the east and west coasts and between 1956 and 1992 America constructed the interstate system, among the largest public-works projects in history, which crisscrossed the continent with nearly 50,000 miles of motorways.

The American transit system is in shambles now. The absence of a true high-speed rail is a continuing embarrassment to the nation. America's fastest and most reliable line, the north-eastern corridor averages a sluggish 70 miles per hour between Washington and Boston. The French TGV from Paris to Lyon, by contrast, runs at an average speed of 140mph. America's trains aren't just slow; they are always late. The train journey between Detroit and Chicago is always unreliable and dangerous. Trains creep out of main city stations and pause at intervals, inexplicably, as they travel through the suburbs of Detroit.

Air travel is no relief either. Airport delays at hubs like Chicago and Atlanta are as bad as in any underdeveloped country. Overbooked airports frequently lead to runway congestion, forcing travelers to spend long hours stranded on the tarmac while they wait to take off or disembark. Airport conditions in major cities like New York can bring tears to one's eyes. Mass transit in major American cities does not exist with the exception of New York, Boston, Washington DC and San Francisco. America's dependence on its cars is reinforced by a shortage of alternative forms of transport. Many will argue otherwise, but the fact remains, "if you build them, they will come."

The Congress and the President are not doing anything about this either. The government is paralyzed due to partisanship. The American public seems to care less. Their focus is on same-sex marriage, abortion rights, and diversity. This is all due to years of social engineering by Hollywood and the media. Roads, bridges and railways used to be neutral ground on which the parties could come together to support the country's growth. After asking for her senior discount in a greeting card store the lady in front of me put three identical cards on the counter. They read, "To My Best Friend."


After our over-55 senior softball team's annual golf outing we had pizza and beer in the backyard of our leftfielder's home. As we sat at poolside re-




The hand: the Demise of the Neanderthal by Nick Meyer

"A captivating read. Right from the start of the novel, I was



drawn in by the compelling dedication through the words of Dalai Lama...The first page got me rather intrigued, and I haven't lost my interest till the very end. As I finished, I asked myself: what is worthier in this book - the plot or the premise? And I couldn't decide... It's more than just a nostalgic look at the Neanderthals. It's a message, quite a

significant one. It's an honest look at our society and how much we need to learn from history (even such an ancient one!) to make it better; it's a bold venture into the mysteries of human mind and spirit; it's an undaunted analysis of meditation and thought travel, of the power of touch, of the quirks of destiny, of mutation and inbreeding, of the apparent connection between religious texts and major historic developments, and finally the all-present DNA. I have to admit, this novel made me scramble and refresh my knowledge of history by googling all sorts of sites – and that's a good thing: if a book does that - it's part of its merit. I admired the ease with which the author dealt with both the past (very, very remote past in history) and the present moment, changing from one to the other effortlessly within the plot. As for the writing style, interestingly, it reminded me of reading a play - each movement of the characters described so much in detail, though more so in the sections covering the present... All in all, this book gave me a lot of food for thought." -Reviewed by Irene Rudra



The Sheltering Sky

"I think this is one of those books that are open to wide interpretation. Apart from eloquent description of the Sahara desert and its culture, it's a daring and exploratory trip into human psyche.

On the surface of it a young American couple (even though in name only, for the moment), moderately seasoned by travel up to this point, with another friend by their side, escape to


travel in North Africa, away from Europe, ravaged by Second World War. That's one thing. But dig deeper, and there is more to it. The two main characters agonizingly struggle with their feelings and intentions, revealing them (in their own minds) with brutal honesty that brings forth painful, raw emotions. Kit is fighting a feeling of constant doom that sometimes totally paralyzes her, leaving her deeply unhappy and disturbed; Port is dealing with issues of rekindling their

relationship (if only she could think "his way"...) and seemingly cannot escape from the "cage he had built long ago to save himself from love". Both agree that Sahara can somehow be a magic remedy for them; and for both, as Port declares, the following is true: "We've never managed, either of us, to get all the way into life. We're hanging onto the outside for all we're worth, convinced we are going to fall off at the next bump. "The third companion plays the part only to the extent of being a pawn - they resort to him when needed and then they avoid him. Not that he doesn't deserve such treatment - for he has his own selfish motives that brought him on this journey. The first part of the book is mostly this kind of pensive mental struggle, in the second one - the struggle becomes physical, brought on by the alien to them climate and culture and by other trials. From this point

it becomes more than just painful philosophical ruminations on life and their place in it. Struggle for survival ensues. For one of them the end is ambiguous. A local man observes to Kit: "Here we say that life is a cliff, and you must never turn around and look back when you are climbing". But even a statement like that, close to the end of the book, could not lift the oppressively heavy feeling I had after reading it. The book wore me out. Emotionally. Plus, one thing that I thought lacking - the history of the couple's relationship leading up to this extraordinary and tragic trip through North Africa (the meager hints of that didn't seem to be enough). "

Learn from India or Leave Her Alone

Lately, there have been rampant attacks on India by the western press and their political leaders blaming her people of being religiously intolerant and rape mongers. These attacks stem from ignorance and Hindu phobia. Even President Obama made a parting shot at Mr. Modi during his recent visit to India, "Nowhere is it going to be more necessary to uphold (religious faith) than in India. India will succeed so long as it is not splintered on religious lines."

India has been there for thousands of years, unique and all encompassing. The rest of the world should learn from her uniqueness and not pass moral judgment on her. Here are some facts to support my statement.

According to National Human Rights Commission of India and National Commission for Minorities, over 2005 to 2009 period, an average of 130 people died in India every year from communal violence which equates to about 0.01 deaths per 100,000 population. Though I could not find the number of deaths due to hate crime in the USA, according to the FBI hate crime statistics, there were 1,318 anti-religious crimes reported in 2011. A number of them were conducted against Sikhs, Muslims. Jews and Hindus. In 2014, 5,928 hate crimes were reported in the US which comes to around 2 per 100,000 people.

Even one murder or rape is too many. However, the United States ranks 9th among all nations in number of rapes committed. India's position is a distant 46th. According to the National Violence Against Women Survey, 1 in 6 U.S. women and 1 in 33 U.S. men have experienced an attempted or completed rape in their lifetime. More than a quarter of college-age women report having experienced a rape or rape attempt since age 14. Overall, only 16% of the total cases are reported. The rate of rape in the US is 28.6 per 100,000 people. In India it is 1.6 per 100,000. According to the FBI report, here is a table of rapes committed per 100,000 people in various states of the United States of America:

The uniqueness of Indian culture lies in its geographical diversities, natural wealth, vast population and people's attitude among other things. There are few countries, which have extreme climatic conditions like India has. When people in the northern parts of the country would be shivering with chilling cold one can find people in the south bare feet.

The uniqueness of Indian culture is its composite and pluralistic nature. In no other part of the world has religious and cultural plurality co-existed and cross-fertilized each other so creatively. While Christians fought their denominational wars in the western hemisphere, Indian

Christianity remained free from confessional conflicts and sectarian tensions. Shias and Sunnis in India do not kill each other as their counterparts do in our neighborhood. Sikhism and Sufi mysticism witness the synergy of Hinduism and Islam. These, are the authentic signs of the vitality and creativity of Indian culture. Togetherness is the essential character of our way of life. It is this spirit of togetherness that welcomes and blends diverse elements that seem disparate outside of that framework. India is a unique example of spiritual and cultural unity-in-diversity that should be adopted by the rest of the world.

Life in Ferguson, Missouri

Life in Ferguson Missouri (a suburb of St. Lois) was quite normal and peaceful until Michael Brown, an 18-year-old black man, was fatally shot by Darren Wilson, 28, a white police office on August 9, 2014.

Brown and his friend Dorian Johnson were walking down the middle of the street, shortly after robbing a convenience store owned by an opportunist entrepreneur of Asian–Indian descent who came to this country with only eight dollars in his pocket and built a life for his family and himself in a temporal way. Brown and Dorian also confronted the Asian-Indian shopkeeper and scuffled with him for justice and equality. As I said earlier, Life in Ferguson Missouri was quite normal and peaceful until Michael Brown, an 18-year-old black man, was fatally shot by Darren Wilson, 28, a white police office on August 9, 2014.

Soon after the robbery, Brown and his friend were walking the streets of free America minding their own business when a racist White cop, Darren Wilson interrupted their pursuit of happiness, one of the unalienable rights granted to all Americans mentioned in the United States Declaration of Independence. The cop asked Brown and his friend to move to the sidewalk. Brown, an oppressed but a self-respecting brave man got reminded of the age-old injustice and tyranny of the Blacks at the hands of a White majority. He decided not to give up and struggled through the window of the police vehicle until Wilson's coercive gun was fired as a result of the struggle. Brown and his friend fled in different directions. In the entire altercation Wilson fired several shots. One of the shots ended Brown's glorious life.

The shooting sparked protests and unrest in Ferguson. Stores were burnt and looted and houses were vandalized symbolizing black anger against the unfair white establishment. The response of area police agencies in dealing with the protests received significant criticism from the media and politicians. The talking

heads on the television drew a parallel between the Ferguson incident and the Civil Rights Movement of the fifties and sixties.

A few days after the shooting, the Ferguson Police Department hurtfully released a video of the convenience store robbery that occurred only minutes before the shooting. The timing of the video release received criticism from the unbiased media as malicious and untimely. It was labeled as an impediment to the advancement of the civil rights.

On August 18, President Obama announced that the Department of Justice had launched an independent, federal civil rights investigation into Brown's death. On August 22 Supreme Court Justice, Ruth Ginsberg said in an interview with *The National Law Journal* that the events at Ferguson point to a "real racial problem" in the U.S. On September 4, Eric Holder announced that the Justice Department will investigate Ferguson police force for possible misconduct or discrimination

Unfortunately, none of the above mattered to the racist grand jury who announced on November 24 that the policeman had acted in self-defense and appropriately. Following the grand jury announcement, protests, some of them violent, broke out in Ferguson and other cities across the United States. Several Ferguson businesses were looted and fires set by protesters—Protests erupted in cities across the US including, St Louis, Philadelphia, Seattle, Albuquerque, New York, Cleveland, Los Angeles, Oakland, Minneapolis, Atlanta, Portland, Chicago and Boston.

Brown is a martyr and will be remembered as the epitome of America's racial problem along with Rodney King and likes.

Police Brutality Protests Are Justified

The recent incidents of police brutality have become a fixture of the news cycle and rightly so. As a matter of fact, there was no reason to gun down Michael Brown in Ferguson, MO or to kill a 12-year-old boy in Cleveland or to choke a cigarette seller to death in New York. These incidents have enraged the citizens and they are rightly protesting police brutality across the US. Police misconduct is a systemic problem in America and the only way to come up with a solution is through mass protest against it.

The police brutality in America seems something like a legal Wild West. Such gun wielding is not heard anywhere in a civilized world. According to the Economist magazine, "Last year, in total, British police officers actually fired their weapons three times. The number of people fatally shot was zero." Unlike other civilized countries, police here are often equipped with weapons powerful enough to conquer a small country. Police use of highly armed SWAT teams has risen by 1,500 percent in the last two decades, and many police departments have cultivated an "us vs. them" mentality toward the public they ostensibly serve. Although possession of these weapons does not cause misconduct, as the old saying goes, when you have a hammer everything begins to look like a nail.

The public face of a police brutality victim is a young man who is Black or Latino. For example, the "stop and frisk" policy has been explicitly aimed only at black men. Since 2008, this has led to 99,980 stops which did *not* produce an arrest in a Florida city with a population of just 110,000. One man alone was stopped 258 times at his job in four years, and arrested for trespassing while working on 62 occasions. Failure to address this issue communicates to police that minorities are a safe target for abuse.

In the above contexts, attempting to raise awareness about police brutality through a civic protest is well justified. Coupled with additional reforms like providing better training for dealing with minorities and body camera use could produce a significant decrease in police misconduct. Hopefully the widespread protest against police brutality will bring about the needed change and will create a trustworthy relationship between the police and the citizens they are supposed to serve and protect.

The concept of this article was guided by two recent events – one in Missouri and the other in New York. According to news reports, people died for no reason; in both cases, Grand Juries found the police officers Not Guilty. Surely they had much more detailed information about the incidents than we will ever have, and no decision that anyone makes – including each of us in our own day to day lives – will satisfy everyone. Court decisions are not infallible, which is why we have higher courts to appeal to, and we all know that sometimes court decisions are reversed. But no matter the decision of whichever court – even the United States Supreme Court - it cannot satisfy everybody. However, once a decision is made, we must obey. We may march, and we may protest, but we certainly may not destroy the society that we live in by proposing to burn it or kill the police force.

When O.J. Simpson was found Not Guilty, there were no riots, no marches, not even a protest. We all accepted the fact that the jury has spoken, and that's that. Therefore, why so much doubt over the actions and decisions of the Grand Juries here? It seems to this writer that if one hides behind the façade of principle, one should be offended by both or none.

Lastly – Bullying Prevention




Sadly there are lots of friends at school with rude abnormal behaviors. Children should be advised to stay away from trouble and do not get involved with fights.

Ebola Virus Disease

Ebola Virus Disease, also known as hemorrhagic fever, is a serious life threatening disease caused by Ebola virus. This virus is transmitted to human beings from wild animals such as fruit bats, monkeys, gorillas, chimpanzees, and antelopes. According to a recent news article from World Health Organization in 2014, the deadly outbreak in west and central Africa and other third world countries has seen a mortality rate that has climbed to 50-75%.

Scientists have identified 5 strains of the virus, of which four cause disease in humans by direct contact with body fluids from infected persons. A person remains infectious as long as their blood and body fluids, including breast milk and semen, contain the virus.

What is the incubation period?

The incubation period, which is the time interval from infection to symptoms, is roughly 2 to 21 days.

What are the symptoms of disease?

The early symptoms include: fatigue, muscle aches, headaches, and sore throat. Later, these symptoms are followed by high fever, vomiting, diarrhea, rash, kidney and liver problems, and bruises over the body followed by bleeding from gums, intestinal bleeding, etc. Blood tests among infected individuals show low levels of platelets and white counts as well elevated liver enzymes.

What are the treatments modalities?

The supportive treatments include oral and intravenous fluids to prevent dehydration, and secondary infection control by antibiotics. There are no proven treatments available, however, supportive treatments include transfusion of blood products, immune therapy, and new experimental drugs which are being investigated for treatment. There are no new licensed vaccines available on the market; however, daily research is being done at the World Health Organization centers for control of disease for licensing adequate vaccines.



Prevention and control of disease

Good outbreak control relies on applying a combination of interventions, namely case management, surveillance and contact tracing, quality lab services, and social mobilization. Community engagement is key to successfully controlling the outbreak. The risk reduction measures include reducing the risk of wildlife to human transmission contact with infected animals, reducing consumption of raw meats, and using personal protective measures such as gloves, masks, and gowns while handling the animals as well as body fluids from infected persons.

Further outbreak containment measures include prompt and safe burials of deceased individuals identified as having the virus, and personal safety measures as mentioned above. Health care workers as well as lab workers dealing with vaccines or caring for infected persons should apply extra control measures to prevent contact with patient's blood, body fluids, materials such as clothing, and beddings. Personal protective measures include wearing a mask, safety goggles, clean non-sterile long sleeved gown and gloves.

The World Health Organization aims to prevent Ebola outbreaks by maintaining surveillance for Ebola Virus Disease as well as helping those countries where outbreaks have occurred.

The take home message for protecting yourself

Wash your hands frequently with soap and water or an alcohol based sanitizer, avoid touching blood or body fluids such as urine, feces, saliva, or sweat of an infected person, avoiding contact with infected clothing, needles or medical equipment, and recognize the early symptoms and signs of disease.

Can't anyone stop them?

Many words offensive to minorities are deemed politically incorrect and are banned. These censorships are

Having their names and picture on the front page of every newspaper and on nationwide television is the fame these nonentities seek, even in death. In fact, one killer of eight left a suicide note, reading, "Now I will be famous." This is true of the copycat crimes of other evil nutcases. We must prevail upon the media to withhold their identity that will take away their motive. This action outweighs the public's right to know.

Crew Resource Management

Suppose you are a junior pilot on a plane that is getting ready to land. The instruments indicate there is a problem with the landing gear and the captain is going through his protocol for troubleshooting the problem. He requests from the control tower that the plane be allowed to go into a holding pattern until the issue is resolved. After some time you see that the fuel gauge indicates that the plane is running low on fuel. You let the captain know but in his preoccupation with the landing gear issue, he doesn't really pay attention to what you are saying.

What would you do? It seems that you reject any deference to rank or protocol and do whatever you had to do to make the captain hear you. Incredibly, that's what happened on United Airlines flight 173. The pilot was troubleshooting an indicator light that apparently showed the landing gear in the nose had failed to deploy. Both the first officer and flight engineer warned the pilot that fuel was running low. But apparently, so engrossed was he, that by the time he realized, it was too late and the plane crashed. Post-crash it was determined that the landing gear was properly deployed the whole time, the indicator light was merely burned out.

Other mishaps that could have been avoided with proper communication among the members of the flight crew. Human error caused most accidents, 60-80%. In 1979, NASA investigated. From these mishaps, a standard for flight crew communication emerged call CRM (Crew Resource Management) emerged, along with training to implement the skills required. These mastery of the skills can be challenging because they can run counter to social instincts.

The following five steps represent an assertive statement process developed by a CRM expert. It gives a good idea of what is required of an individual.

- Opening or attention getter Address the individual. "Hey Chief," or "Captain Smith," or "Bob," or however the name or title that will get the person's attention.
- State your concern Express your analysis of the situation in a direct manner while owning your emotions about it. "I'm concerned that we may not have enough fuel to fly around this storm system," or "I'm worried that the roof might collapse."
- State the problem as you see it "We're showing only 40 minutes of fuel left," or "This building has a lightweight steel truss roof, and we may have fire extension into the roof structure."
- **State a solution** "Let's divert to another airport and refuel," or "I think we should pull some tiles and take a

look with the thermal imaging camera before we commit crews inside."

• Obtain agreement (or buy-in) - "Does that sound good to you, Captain?"

On July 19, 1989 United Airlines Flight 232 an engine fan broke apart resulting in the loss all three independent hydraulic systems, leaving the plane with almost no controls and just the two remaining engines. Working together the crew was able to crudely guide the place by altering power to each of these engines. The landing was rough, but of the 296 people on board, 185 survived. The pilot gives credit to CRM as one of the factors that saved so many lives:

...the preparation that paid off for the crew was something ... called Cockpit Resource Management....Up until 1980, we kind of worked on the concept that the captain was THE authority on the aircraft. What he said, goes. And we lost a few airplanes because of that. Sometimes the captain isn't as smart as we thought he was. And we would listen to him, and do what he said, and we wouldn't know what he's talking about. And we had 103 years of flying experience there in the cockpit, trying to get that airplane on the ground, not one minute of which we had actually practiced, any one of us. So why would I know more about getting that airplane on the ground under those conditions than the other three. So if I hadn't used [CRM], if we had not let everybody put their input in, it's a cinch we wouldn't have made it.

CRM has proven invaluable in saving lives on many other flights.

The basic ideas of CRM have been applied to other fields. Anywhere that the stakes are high, there are several people contributing skills to the situation, and time is of the essence (to varying degrees), is ripe for application of CRM principles. Even considering the five points above, and applying them to real life situations would be of great benefit.

People really are our most important resource, and people who don't realize that and choose not to live that way, choose not to lead that way, are paying a price for that in many of our companies, many of our organizations.

Minimum Wage and Immigration

Two recent decisions at the national level have left all of us with an opinion, and have divided us like no other issues since abortion, civil rights, and gun control.

The first issue is the minimum wage. It has been raised in many places since January 1st, 2015. Michigan's minimum wage is currently \$8.15/hour and scheduled to increase to \$9.25 in January, 2018. Chicago is currently at \$10.00/hour, and the suburban Seattle, a city where Boeing is located is at \$15.00/hour. Currently, an annual income of \$22,500 a year puts one below the poverty level. If one works full time, 40 hours per week, and still is below poverty level, what is the point? 




