

Nothing Happens in This Town


That's very true. Nothing has changed in this town called

fAs if apocalyptic earth quakes, volcano eruptions, strong solar flares, giant meteorites hitting the earth were not enough cataclysmal events to annihilate us, I just discovered one more to scare us out of our wits. It's called Earth's Magnetic Field Flip.


Original - How Non-Conformists Move the Wo

Penguin Books (Paperback, 254 pages)

Adam Grant's "Original – How Non-Conformists Move the World" is a book for independent thinkers. The book is an interesting read from the beginning to the end inasmuch as Grant supports his premises with unique examples. His case studies include Warby Parker who dared to sell eye glasses at much lower prices than the established optic shops. Grant identifies 30 action steps that people in all walks of life can take to be successful.

Grant emphasizes the importance of innovating thinking as opposed to conventional thinking using interesting terminologies such as 'false negative' which means presuming failure of an action while it (action) may ultimately succeed. Grant stresses originality that stems from viewing a familiar world or situation in an unfamiliar way. Grant makes the argument that to be an original propelling the world forward, risk-taking is inevitable but not to the same degree most of us would imagine.



I found that the anecdotes presented in 'Original' to be too lengthy which reduces the clarity of the messages Grant wants to convey. After reading Malcolm Gladwell's books, especially Outliers, Grant's presentation looks less effective and more cumbersome, nevertheless, Originals is a great book that encourages changing the way we live and think. –


Avarna - The Veil Author: S L Vyrappa Published by Rupa (389 pages)

Avarana – The Veil is a very provocative novel by the famous Kannada writer, S.L. Bhyrappa. Avarana, the veil is referred here as hiding the truth. The entire novel depicts a forceful struggle between hiding the truth for political correctness and creativity vs. presenting the truth as it is. What should a writer or an artist choose?

In this novel, Bhyrappa has shown courage to remove the veil from inhuman Islamic practices which may not go over well with intellectuals and politicians who try to put a veil over those practices in the name of secularism and inclusiveness.

The story in Aavarana revolves around its protagonist, Lakshmi who was renamed Razia after her conversion to Islam as a precondition to marrying Amir who is a Muslim. Razia is forced to eat beef and follow orthodox Muslim practices by Amir's parents. Amir, who came across as a liberal and secular person first, wants Razia to follow his parents' wishes. Eventually she returns to her ancestral village and to her Hindu cultural roots following estrangement with Amir (who remarries without divorcing her). Razia reads the writings of her father's excerpts and realizes the historical atrocities of Muslims towards the Hindus. She refuses to work on a government sponsored program that intends to hide those facts.

This was my first introduction to Bhyrappa's style. I was deeply impressed by his art of storytelling and the ability to vividly describe situations. I can equate his style to two greatest novelists that I have come across, Premchand (Hindi) and Charles Dickens (English).



However, while Bhyrappa has exposed the fact about Islamic rulers being iconoclastic (the breaking of Hindu temples and idols), he has mentioned nothing positive about their contribution to India such as iconic architectural structures, literature or intellect (Sufis for example). His depiction of the Muslim life in India is entirely negative. All the Muslim characters in the novel are conservative and closed-¬minded.

The novel's English translation is lucid and pleasing to read. Overall, Bhyrappa is convincing in his argument that an artist should not hide truth in search of beauty. –Reviewed by 'Musafir'



Two Nations Divided by Democracy

Although I am not in favor of impeaching president Trump nor is there any possibility of his impeachment, he would have certainly been removed from the office by now under the British parliamentary system. Though both UK and USA are democracies, yet they have wide fundamental differences as the latter follows a presidential form of government. In the presidential system, once elected, the incumbent escapes the public grilling and day to day accountability as happens in a Parliamentary System.

The House of Commons is an arena where the strength or the weakness of a leader gets quickly exposed with many a stalwart having had to resign on the floor of the house.

The list of Prime Ministers who had to resign despite having a majority in the house, is a fairly lengthy one, indicating the strength of a parliamentary democracy. Tony Blair despite winning three consecutive elections for the Labor Party faced criticism for his support to the US for the invasion of Iraq. In the face of mounting criticism, he had to resign midway through his third term, while President George W Bush went on to complete his second term virtually unscathed.

Following Mr. Blair, David Cameron resigned because the British people voted for Brexit despite his opposition to it. Cameron said, "The will of the British people is an instruction that must be delivered."

While almost a dozen of British prime ministers had to resign because they lost no-confidence motion in the parliament including the stalwart like Benjamin Disraeli, in contrast, except in case of Richard Nixon, there have been virtually no resignations from the top office. Nixon had to go for criminal obstruction of justice in the Watergate affair, several of his staffers having been already jailed.

Bill Clinton went on to serve two full terms despite being only the second U.S president to be ever impeached. He went on to complete his second term despite the impeachment. He won't have survived the House of Commons, had he been in UK, facing a similar situation.

Despite serious foreign policy issues, Jimmy Carter went on to complete his first term, albeit with difficulty and failed to get reelected. US Presidents thus have a certain degree of insularity.

A strong political party system with emphasis on discussion and debate and even occasional dissent, has been the strength of the House of Commons in Britain.





It is difficult to say which system is better. The British parliamentary system threatens the stability of the government without giving a chance to the prime minister to show the long-term benefits of his or her policies. At the same token, a misguided president may paralyze a nation without much fear of removal from the office causing dire consequences to the nation.

I Am for A Single-payer Health Insurance

According to my understanding a single-payer health insurance system is the best for most Americans. My view is not based on any kind of bias or political agenda.ou may differ from my point of view. If so, I am open t an honest discussion on the subject. Here is what I found.

At the outset, we must be clear about what does a Single-payer health insurance (aka "Medicare for All") mean. It is a health insurance system that is financed by taxes and is managed by one entity, such as our government. This also means that a U.S resident will not incur extra costs when seeking out essential care. It will also cover vision and dental expenditures.

According to my findings, "Medicare for All" will reduce health care spending. Of course, we'll be paying additional taxes (nothing is free), but most of us will not pay more than what we are paying now. Take my case. My wife and I jointly pay more than \$12,000 per year in premium for health, dental and vision coverage. We are retired. We are on Medicare and collect Social Security. Still Social Security takes a big chunk of money from our benefits to cover our basic medical benefits. We have taken supplemental insurance for health and prescription drugs. We also have to pay additional premia for dental and vision that hardly cover half the cost.

Looking at the above, we'll (my wife and I) be better off paying an additional tax of \$12,00 per year which will come to us with peace of mind.

"Medicare for All" will reduce the ballooning health care cost inasmuch as it will drastically reduce the administrative cost by billions of dollars. It will also eliminate the burden of paying emergency room (ER) costs that the taxpayers have to bear for uninsured folks. In the USA, 86 million people, are underinsured. Additionally, millions belonging to the middle class have insurance but they are unable to access medical care because their deductibles or copays are prohibitively high. One of my close friends was in this dilemma for years.

Another major saving will come from the government negotiating down prescription-drug prices, which would save billions. Prescription-drug prices in the U.S. are about twice as high as in other advanced economies. Under "Medicare for All" these prices will fall.

"People can stop worrying about medical bills and having to choose between their health and medical debt which is a major problem in America today. In 2017, a Bankrate survey found that 25 percent of Americans or someone in their family, have foregone medical treatment due to the cost. This included 31 percent of millennials, 25 percent GenX and 23 percent in the Boomer category" (Source: the Physicians for a National Health Program). Add it all up and "Medicare for All" starts making more sense.

I must admit that there are caveats in "Medicare for All" option. Pressuring drug makers in reducing cost of drugs will be demotivating for them to do research and find new cures for the diseases.

The government administered programs have a history of mismanagement. This may add to additional bureaucracy and tax increases every year. Eventually the system may go bankrupt similar to the sword hanging over present Medicare and Social Security systems. To save the system the Congress may pass laws to limit the benefits and the choices of providers.

I recommend the option for private insurance for those who don't want to participate in "Medicare for All". That should make everyone happy.

The Use and Abuse of Opioids Worldwide By Dr. Niru Prasad, MD

Opioids are the class of drugs either derived from or chemically similar to opium poppy seeds derived from a flowering plant.

The opioid epidemic is a world wise deep national and international epidemic killing almost 100 Americans each day, more than the automobile accidents.

What is opium?


The seeds of so called poppy seeds are derived from a beautiful hardy flower papover somniferum 4 feet high in multi-color, grows in temperate climates, needs no fertilizer, attracts few pests, and resemble weeds. The bloom of flower lasts only for a few days and petals fall leaving greenish grey pods. The seeds in pods have no psychogenic effect, however, once the seeds are crushed and dissolved with water while taken orally in different forms, the calming effect and euphoria are produced.

What are opioids?

Opioids are a class of drugs either derived from or chemically similar to compounds found in opium seeds. The opioid group includes: legal prescription pain killer like oxycodone, morphine, codeine, fentanyl and more. Sadly, heroin which is illegal is also an opioid. The prescription drug can be taken orally, as a film patch that dissolves in mouth for immediate effect or may be given intra muscular or intra venous for anesthesia. The misuse of drugs by addicted person includes crushed pills as nasal inhalation, or self-injections for a relaxed euphoria and laughter.

What is heroin?

Heroin is sold as an off white or brown powder and can be taken as snorting, nasal inhalation, injected into the vein or inhaled. Prior to inhaling, the powder are generally placed in aluminum foil and burnt over a spoon so the vapors can be inhaled faster.



How do you recognize symptoms of opioid abuse?

The signs and symptoms of opioids use and abuse include: feeling of euphoria, relaxation, nausea, and mental confusion. Opioids work by binding to opioid receptors in the brain reducing the perception of pain, and stimulating the brain's reward's center. Opioids also quickly builds up physical dependence and addictions in individuals if taken frequently.

The world wise epidemics of opioid addictions, signs and symptom of substance abuse include general changes in mood and behavior, drowsiness and depressions and disorientation among the users. Drug paraphernalia among teenagers and young individuals can easily be seen in and around the victim's bedroom or living spaces. Furthermore, presence of drug vials, needles, rubber tubing's and bunt or bent spoons are very suspicious. If taken in higher doses one develops rapid heart rate, difficulty breathing, pin point pupils and loss of consciousness.

The National Institute on Drug Abuse (1-877-643-2644) recommends the following on preventing your children and adolescent drug abuse.

The preventative principles include helping patients, parents, educators, and community leaders to plan for and deliver prevention plans at, schools, with teachers the students and social services.

The potential impact of specific risks and protective factors changes with age and circumstances. The risk factor within family have more impact on young kids while adolescents are more influenced by their peer pressure.

How to prevent opioid abuse?

An early intervention with risk factor (aggressive behavior and poor self-control) are often a greater impact on child than a later intervention.

The risk and protective factors affect all ages, however, they might have a different effect according to their age, gender, ethnicity, culture and environment.

The prevention programs should address the type of drug used alone or in combination with alcohol, smoking, abuse of prescription and nonprescription narcotics and more.

The family based plans enhance family involvement, parenting skills, and help from substance abuse clinics.

Furthermore, these prevention programs are more effective when they involve interactive skills such as peer discussion group parent role and more.

World View: / Why the Fizzled Overthrow of Maduro Reminds Us of Bay of Pigs? By Anil Shrivastava 'Musafir'

America's failed support to uprising in its backyard (Venezuela) last week reminds us of another American debacle 53 years ago this month known as Bay of Pigs. Unfortunately, the U.S. hasn't learned the lesson from its failures not to raise expectation and then at the last moment taking away the support. Why is not the United States, with all its might, able to do anything about the thorns by its side, viz., Venezuela, Cuba and Nicaragua? Maybe, the United States is afraid of 25,000 Cuban troops on top of the Russian troops that were sent to Caracas in March 2019 to support Maduro.

We were late in taking action against Cuba and North Korea and we let them grow as threats to our security. Seems like history is repeating itself in Venezuela. America's weakness is evident from the following exchange. President Trump asked Putin to get out of Venezuela. Putin did not consider worth his time replying to his orders. Instead his Foreign Minister shouted back that the U.S. should get out of Syria first. The fact is that the United States is afraid of confronting Russia in its own backyard.

Just like the U.S. has interest in oil fields in the Middle East, Russia has interest in lucrative gas fields off the coast of Venezuela through its state-owned oil giant, Rosneft. On top of that Moscow has also earned \$11.4 billion selling military equipment to Caracas, and currently exports about \$70-\$80 million worth of non-military goods to the southern country. Not only that, two Russian factories -- one that will make Kalashnikov assault rifles and another that will make ammunition for them -- are currently under construction in Venezuela.

The same is true of Cuba and Nicaragua. The Russian strategy is to confront the U.S. which is grounded in the Kremlin's idea of a new world in which the U.S. doesn't have the absolute power anywhere in the world. The U.S. has a reputation as a late comer to the game and being an unreliable partner. Thus, it is not able to exert its influence even its own backyard. That seems to be the answer to the puzzle.

"VERY URGENT AND IMPORTANT NEWS! Please make it a point of FORWARDING this



If you have been living in the dungeon of cable and network crap, you, probably, don't know that the people of India elected a new parliament on May 23, 2019 for the seventeenth time since India became a democratic republic on January 26, 1950 (not to be confused with Indian independence on August 15, 1947). Narendra Modi's party, BJP (India's People's Party) won the majority for a second consecutive term for another five years. Thus Narendra Modi will retain his position as the prime minister of India since he is the undisputed leader of his party.

Held in seven phases from 11 April to 19 May, 2019 Lok Sabha (lower house) elections saw a galaxy of opposition leaders shed their personal differences to take on Modi. It was probably for the first time that an entire election was fought either in support of or against one man – Narendra Damodardas Modi.

The election was a referendum on Mr. Modi's policy of strong India. BJP (Mr. Modi's party) will attempt to fulfil everything it promised in the party manifesto, including the contentious National Register of Citizens (NRC). Though the opposition, especially West Bengal Chief Minister Mamata Banerjee, has been most vocal against the implementation of the NRC in the states, the BJP will remain undaunted in its goal of identifying illegal immigrants from Bangladesh across the country.

The referendum bears bad news for the Congress Party (liberal and socialist) of India led by Rahul Gandhi, the great grandson of India's first prime minister, Jawahar Lal Nehru and Rahul Gandhi's Italian mother, Sonia Gandhi. The Congress party ruled India for 49 years directly or by proxy. The Congress Party favors illegal immigrants and wants to treat them as Indian citizens with the right to vote as they (illegal immigrants) constitute Congress Party's vote bank.

The Modi government has achieved tremendous success to curb terrorism in the last five years. Thus, there will be no change in the security policy with regard to Kashmir and Left Wing Extremism. On the other hand, the government might come down even more heavily on terrorists. With 2016 surgical strikes and the 2019 Balakot air strike against terrorist camps in Pakistan, PM Modi proved that he was not averse to taking tough decisions when it came to national security.

Mr. Modi and his BJP party will do everything within their power to scrap Article 370 of the Constitution and Article 35A, which give the state of Jammu and Kashmir (the only Muslim majority state of India) an autonomous status and prohibits citizens from other parts of India to settle there while there is no accountability for murdering and snatching properties of their Hindu citizens who have moved to another parts of India as refugees in their own country.

Under BJP-led government military buildup will continue to ensure that India's military strength keeps increasing. New defense deals will be struck as India is still looking to meet the fast depleting numbers of fighter squadrons in the Air Force. Modern and more effective assault rifles for the Army and other equipment needed to guard the borders with Pakistan and China will be procured during Modi's second term.

Hindu hardliners who support the BJP have the Ram Mandir as their demand. The BJP might do everything possible to make the temple a reality by 2024. Lord Rama was Hindu's equivalent of Jesus. The Muslim rulers destroyed his temple and made a mosque in its place. The Hindus want their holy place back but previous governments and the Supreme Court of India have always deferred the decision due to the fear of Muslim retaliation.

A full majority might help the government implement the BJP's push to make triple talaq by the Muslim men a criminal offence. Though passed in the Lok Sabha on multiple occasions, the Bill got stalled in the upper house due to the opposition. Many Muslim women have been sympathetic to the BJP for this very reason and have indicated a favorable inclination towards the BJP. The BJP will, therefore, try to maintain its goal of getting the Bill turned into a law.

Modi will learn from some failed moves such as demonetization and hefty promises of creating smart cities and eradicating all the ills of interstate trade through GST tax reform. The government this time will most likely, will try to steer clear from such policies.

Though India's economy is the fastest growing in the world, the mounting unemployment and poverty in villages is a blemish on India. Mr. Modi will have to solve this dual problem otherwise people may get disillusioned with him.

How does this impact Indo-US relationship? Indo-American bilateral ties will be stronger. The objectives of both countries today are challenged primarily by China. Beijing threatens US hegemony both regionally within Asia and globally, and it threatens India's security and influence along their common borders, in India's near and extended neighborhood, and across Asia at large

Trump's administration has always favored India over Pakistan and worked hard to declare Masood Azhar a terrorist. They will work more intensely against a common enemy, radical Islam.
